Life Drawing Stock Art, many also known as Wildlife Clip Art, its documentation and related materials are copyrighted 1999 - 2006 by Zack Zdinak, sole proprietor, Life Drawing and Education. You may not copy or reproduce any part of the Life Drawing Wildlife Clip Art software or manual, except as permitted by the Copyright Act of the United States, Title 17, United States Code.

This license permits **One-Time Use** of Life Drawing Wildlife Clip Art illustrations as Stock Art by the User (purchasing company or individual) in products and services described below, as well as the User's contractors in the limited use described below.

This license does not permit the transfer of use or copyright to other companies, individuals, purchasers and/or other worksites. This license does not permit any use of Life Drawing Wildlife Stock Art by the recipients, users or purchasers of products or publications containing clip art in other products or publications.

COMMERCIAL ONE-TIME USE: Users may include stock art images one time per payment in one design, product or publication for sale or to promote the sale of products, publications or paid services (i.e.: sale newsletters with limited circulation, publications, commercial interpretive panels and exhibits, advertisement, business logos, cards and letterhead, commercial websites and design). Any changes or updating of the design, product or publication for clients or events constitutes a new use and would require payment. One-time is defined for publications, gift cards, clothing printing and other reproductions as each production run up to 2500 copies of one item. Such commercial uses and products cannot be sold or marketed as stock art or clip art.

CONTRACT USE: Within the One-Time Use limitations described above, a User may authorize contracted service providers (ie: publishers, designers, etc) to print and/or manufacture products or publications containing stock art. Users must require service providers to: adhere to all copyright requirements herein, limit use of stock art only for User-specified products and publications, and return all clip art files and hard copies to User or delete them upon completion of contract.

WEBSITE USE: In addition to the copyrights and license limitations above, TIFF images of Life Drawing Stock Art or parts thereof **MUST BE REDUCED TO 72 dpi** (GIFs, JPEGs) for use on the Internet and included in web pages. EPS images are not for use on the Internet or web pages.
